Subject: BUSINESS APPRENTICESHIP FUNDING

1.0 PURPOSE:

- 1.1 The purpose of this report is to seek Cabinet approval to extend the 'Changing Lives Building Business Scheme', by committing a further £100,000 through the One Off Fund.
- 1.2 The scheme will provide a £2,000 grant targeted at supporting small businesses, particularly those with less than 10 employees, to provide placements for apprentices.

2.0 BACKGROUND:

- 2.1 In June 2012, Cabinet agreed to provide £100,000 through the One Off Fund to develop and deliver a scheme to encourage young people into work through apprenticeships in the Council and in the private sector. The scheme was launched in September 2012 in partnership with the National Apprenticeship Service and Job Centre Plus. By mid-October 2012, 25 businesses had registered an interest in appointing an apprentice.
- 2.2 In September 2013 an evaluation of the first year was undertaken. In this time, 5 apprentices had been appointed in the Council, taking the total number of Council apprentices to 15. In addition, 12 businesses had also appointed an apprentice. The Scheme has not seen any apprentices drop out from their placements.
- 2.3 In the private sector, the project has seen 6 young people obtain permanent jobs and 4 others have formal qualifications and commitments to further training to improve their employment prospects. Other economic benefits include business growth through businesses planning to employ more staff, businesses moving to better premises and increasing sales.
- 2.4 The feedback has been very positive from the supported businesses with many saying they wouldn't have taken on the risk of an apprentice without the financial support from the Council.
- 2.5 The £100,000 will be directed at small businesses to extend the scheme for the next 2 to 3 years.

3.0 LINK TO COUNCIL PRIORITIES:

3.1 One of the Council's key priorities is to support local economic growth. By getting young people into employment and training and supporting businesses to do this, the Council will be directly supporting economic growth within the Hambleton District.

4.0 RISK ASSESSMENT:

4.1 There are no significant risks associated with approving the recommendation.
