# C.42 SUNBED (REGULATION) ACT 2010

All Wards

The Head of Regulatory Services submitted a report regarding the Sunbeds (Regulation) Act 2010 which came into force on 8 April 2011. The purpose of which was to prevent people under the age of 18 years from using sunbeds on commercial premises by making it an offence which carried a fine not exceeding £20,000.

The Act also contained powers to make regulations in relation to sunbed use, sale or hire. These included the power to ensure all sunbed use was supervised and the power to ensure that sunbed businesses provided prescribed health information to sunbed users and the requirement for securing the use of protective eyewear.

It was recommended that the responsibility for the regulation of this legislation be delegated to the Licensing and Environmental Protection Committee.

#### **THE DECISION:**

That all functions relating to the regulation of sunbeds be delegated to the Licensing and Environmental Protection Committee.
