C.17 CABINET MEMBER STATEMENTS

- (a) Councillor R Kirk, Cabinet Member for Corporate Management made a statement regarding the new method of reporting financial information, Shared Services and Performance Monitoring.
- (b) Councillor P R Wilkinson, Cabinet Member for Leisure and Health made a statement regarding Asset Transfer; Olympic Torch Relay; Films at Hambleton Forum; the Food Hygiene Rating Scheme Relaunch; Flexible Warrants and provided an update on Sports Activities. A question relating to the timescale for implementing the Food Hygiene Rating Scheme was asked and responded to.
