Subject: **APPLICATION FOR THE RENEWAL OF A PRIVATE HIRE VEHICLE LICENCE
CARLTON CARS (N YORKS) LTD – PH76**

1.0 SUMMARY

1.1 Members are asked to consider whether or not to grant an application for the renewal of a private hire vehicle licence.

2.0 PROCEDURE

2.1 The procedure for licensing hearings is attached as an Annex to the Agenda.

3.0 BACKGROUND

3.1 Since 1st November 2016, Carlton Cars (N Yorks) Ltd have held a private hire vehicle licence (plate number PH76) in respect of a Volkswagen Golf, vehicle registration mark SB02 TBX. The licence is due to expire on 31st October 2017.

3.2 On 5th October 2017, Carlton Cars (N Yorks) Ltd applied to renew the private hire vehicle licence pertaining to the vehicle. A copy of the application form is attached at **Annex A**.

3.3 All applicants are required to produce the following documents before a licence will be renewed:

- a current MOT Certificate;
- proof that the licensing authority's testing arrangements have been satisfied (i.e. a test paper completed and signed by a Hambleton-based VOSA-accredited testing station); and
- a current vehicle insurance certificate or cover note which includes the carriage of passengers for private hire;

3.4 The applicant has produced the requisite documents listed in paragraph 3.3 and copies are attached at **Annexes B, C & D**. The documents have been accepted and validated by licensing officers.

3.5 The MOT history of the vehicle has been taken from the GOV.UK website and is attached at **Annex E**.

3.6 The most recent MOT certificate shows that, on 21st September 2017, the recorded mileage was 154,064 miles.

3.7 According to the registration document, attached at **Annex F**, the vehicle in question was first registered on 4th July 2002.

4.0 POLICY CONSIDERATIONS

- 4.1 In carrying out its licensing functions, the Panel should have regard to the council's Hackney Carriage and Private Hire Licensing Policy.
- 4.2 In accordance with paragraph 3.2.1 of the policy, the council will generally only grant a licence in respect of a private hire vehicle if it is less than 10 years old at the time of the application. For these purposes, the age of the vehicle shall be taken from the date of first registration. The vehicle in question surpassed this general age limit in July 2012.
- 4.3 The Licensing Committee approved the adoption of an age policy on 11th February 2016 having satisfied itself that it was appropriate to promote public safety, reliability and improved high standards of hackney carriage and private hire services in the district.
- 4.4 The council's policy can (and is generally likely to) affect the outcome of the decision in most cases and this is entirely lawful. The policy is a means of securing a consistent approach to individual cases.
- 4.5 Each case must be considered in the light of the policy but not so that the policy automatically determines the outcome¹.
- 4.6 According to the minutes of the meeting on 11th February 2016, the Licensing Committee acknowledged that the policy allowed exceptions to the general rule by placing a requirement on the licensing authority to consider each application on its individual merits and to depart from the general policy where the specific circumstances of a case justify making an exception.
- 4.7 The onus is on the applicant to demonstrate that any such exception should be made².

5.0 DETERMINATION BY THE PANEL

- 5.1 Members are advised to take one of the following steps:
- 5.1.1 The Panel may conclude that the specific circumstances of the applicant's individual case justify making an exception from the general policy, in which case, the Panel may grant the application; or
- 5.1.2 The Panel may refuse to renew the licence on the grounds of any reasonable cause.
