Subject: COUNCIL SIZE AND ELECTORAL ARRANGEMENTS

1.0 PURPOSE AND BACKGROUND:

- 1.1 The Council has agreed in principle to ask the Local Government Boundary Commission (LGBC) to undertake a review of electoral arrangements at the Council with a view to reducing the number of Councillors. The Council has indicated its initial view that the appropriate number of Councillors should be 22. By natural process the LGBC have indicated the Council is also due for a periodic electoral review as some ward/elector ratios are out of balance by more than 10%.
- 1.2 The LGBC has indicated that the review will formally commence in March 2012. This report suggests a procedure for determining and evidencing the Council's initial proposals on Council size and warding prior to submission to the LGBC.

2.0 **SUGGESTED APPROACH:**

- 2.1 The LGBC sets out in guidance the evidence which should be provided and the issues which should be considered in reaching conclusions on electoral arrangements. The Council has already determined that some form of consultation be undertaken.
- 2.2 It is recommended that an Electoral Arrangements Working Group be established to consider detailed proposals, undertake consultations and make recommendations to Council. It is suggested that the Working Group be made up as follows:-
 - Leader/Deputy Leader of the Council
 - 4 nominees from Conservative Group
 - 1 nominee from each of the other Party Groups
- 2.3 The following is a suggested timescale for the Working Group's activities:-

Initial meeting(s) to agree proposals for consultation with Parishes	September/October 2011
Consultation (Seminar for all District Council Members; Letter to all Parishes)	November/December 2011
Consideration of consultation responses	January 2012
Report to Council	February 2012

- 2.4 Prior to the first meeting of the Working Group Members will be asked to complete a questionnaire on the time they spend on Council business to inform the review.
- 2.5 It should be remembered that the LGBC will be conducting its own consultations over an extended period during 2012 and there will be further opportunities for the Council to consider its position.
