Subject: ELECTORAL ARRANGEMENTS

All Wards Scrutiny Committees Leader: Councillor N W Huxtable

1.0 PURPOSE AND BACKGROUND:

- 1.1 In January 2011 Council agreed in principle to request the Local Government Boundary Commission (LGBC) to undertake a review of Council size.
- 1.2 In September 2011 Council agreed to set up a Working Group to advise on the Council's initial submission to LGBC.
- 1.3 This report provides feedback from the process so far and recommends a proposal for submission to Full Council.

2.0 <u>DECISIONS SOUGHT:</u>

2.1 To recommend to Council a proposal on Council size to be submitted to the LGBC.

3.0 THE PROCESS SO FAR:

- 3.1 The Electoral Arrangements Working Group has initially consulted with Parish Councils and District Members on a proposed Council size and Warding arrangements based on 22 Members which was felt presented a workable option in line with the Councils initial consideration of possibly reducing numbers by up to 50%. Based on responses and a wider member seminar it has subsequently considered a further two options based on Council sizes of 28 and 32 Members.
- 3.2 The report presented recently to the Working Group is attached as an Annex to this report.
- 3.3 The Working Group accepted that there was sufficient evidence to support a significant reduction in Member numbers. It has had regard to the LGBC's Key Lines of Inquiry and views expressed so far in reaching a conclusion. As such a majority of the Working Party supported an option of a 28 Member Council. This could provide for a warding arrangement as set out on Plan 4 attached to the report to the Working Group. This would contain 14 Wards with a mixture of 1 Member, 2 Member and 3 Member Wards. Details of which parishes could be contained in new Wards and the number of Members for each Ward are attached in a Schedule.
- 3.4 The Working Group feels that a size of 28 meets the balance of reflecting reductions in Member workloads whilst maintaining the ability to achieve community identity and effective and convenient local government.
- 3.5 It should be borne in mind that the proposals on warding are simply illustrative of how a 28 Member Council could be warded. At this stage the Council would simply be supporting a revised Council of 28 Members. The details of warding arrangements would be dealt with as the second phase of the LGBC's work.

4.0 NEXT STEPS:

4.1 The LGBC wishes to reach a preliminary view on Council size in March. There would then be extensive consultation before the LGBC reached its final view on Council size. There would then be a second exercise when actual warding arrangements would be considered.

5.0 LINK TO CORPORATE PRIORITIES:

5.1 Efficient and effective Member decision making and scrutiny processes are key to delivering the Council's priorities.

6.0 RISK ASSESSMENT:

- 6.1 There is a significant risk that if the Council does not make any proposal it will lose influence in the process. Equally, the Council needs to make a realistic proposal. The LGBC have made it clear that proposals for Council size less than 30 will require special justification. However, there have been indications that it might be prepared to consider a size of 28 for initial consultation.
- 6.2 There is a slight risk that the LGBC will not accept a proposal of 28 Members, but the implications for the Council are minimal.

7.0 SUSTAINABILITY IMPLICATIONS:

7.1 None.

8.0 FINANCIAL IMPLICATIONS:

- 8.1 The work involved in being part of the review can be met from existing resources.
- 8.2 The financial effects of amending Council size cannot be taken into account as part of the review.

<u>ELECTORAL ARRANGEMENTS WORKING GROUP - 24 JANUARY 2012</u> SUGGESTED PROPOSALS FOR ELECTORAL REVIEW

1.0 BACKGROUND:

- 1.1 The Council has agreed in principle to ask the Local Government Boundary Commission (LGBC) to undertake a review of electoral arrangements at the Council with a view to reducing the number of Councillors. The Council has indicated its initial view that it would like to see a reduction of up to 50% which taken literally would see the appropriate number of Councillors as 22. The LGBC have confirmed that the Council is also due for a periodic electoral review as some ward/elector ratios are out of balance by more than 10%.
- 1.2 The Working Group has considered initial proposals based on a reduction of Councillors to 22 and has undertaken consultation with Parish Councils/Meetings and District Councillors.
- 1.3 The LGBC has indicated that the review will formally commence in March 2012. This report provides an opportunity to consider feedback on the Council's initial proposals and to formulate proposals to be put to the LGBC.

2.0 LGBC GUIDANCE:

- 2.1 The LGBC's Guidance makes clear that the general approach of the LGBC will be to follow the statutory requirements. These are:-
 - the need to secure equality of representation;
 - the need to reflect the identities and interests of local communities;
 - the need to secure effective and convenient Local Government.
- 2.2 In addition, a number of other factors will be taken into account:-
 - the relationship between District Ward boundaries and County Divisions;
 - potential changes in electorate numbers in the next 5 years;
 - location and boundaries of geographic features and parishes;
 - whether single or multi Member Wards are appropriate.
- 2.3 The LGBC's key Lines of Enquiry on Council size are attached as Annex 1.

3.0 COUNCIL SIZE:

3.1 Although the Council has already agreed in principle that it believes a reduction of up to 50% in Member numbers would be a desirable outcome, this still has to be justified to the LGBC and therefore the question of size is considered first.

- 3.2 The LGBC Guidance is clear that Council size depends on the requirements of individual Council areas. Consequently there is no specific guidance on appropriate numbers and the LGBC will not base its decisions on comparisons between Local Authorities.
- 3.3 We are expected therefore to consider what is the optimum number of Councillors to allow the Council and individual Councillors to operate effectively. The following factors may be relevant:-
 - model of local governance (in Hambleton's case the Leader and Cabinet Model);
 - workloads of Councillors within the Council structures (this may be affected by the type, number and size of Committees and number of meetings);
 - workloads of Councillors outside Council structures (this may be affected by time spent on constituency work, number of parishes served, etc).
- 3.4 The first issue to consider is what is the optimum size of the Council in terms of Councillors to be fit for purpose going forward. On the basis that the Council would continue to operate the Cabinet and Leader model and that the demands placed upon the Leader and his/her fellow Cabinet Members were unlikely to decrease, it is suggested that the recently amended arrangement involving a Cabinet of 5 plus the Leader is the appropriate size.
- 3.5 Turning to the Scrutiny function, the number of Committees and Members involved has recently been reduced. This appears to be operating satisfactorily and has reduced the need for some Members to attend Scrutiny meetings. It is noticeable that attendance at the remaining Committees has improved. It is not recommended that further changes be made at the present time, but there is the option of moving to one main Scrutiny Committee with continued use of task and finish groups to work on the detail of scrutiny reviews. In the context of shared services some scrutiny on matters of common interest may also be relevant.
- 3.6 In respect of other Committees, these fall into two broad categories:-
 - 3.6.1 Committees scheduled to meet on a regular basis:-
 - Planning
 - Audit and Governance
 - Standards
 - Area Forums
 - Joint Committees (North Yorkshire Building Control and North Yorkshire Audit)
 - 3.6.2 Committees meeting on an ad-hoc basis:-
 - Licensing and Environmental Protection Committee
 - Licensing Hearings Panel
 - Standards Sub-Committees
 - Appeals Committee

- 3.7 The Planning Committee has reduced its membership significantly within the last three years. There may be scope for combining the activities of the Planning Committee and Licensing and Environmental Protection Committee into a Regulatory Committee. The Licensing Hearings Panel would need to be retained to deal with licensing applications, reviews, etc. but it could be reduced from 5 Members to 3 Members in line with most quasi-judicial panels.
- 3.8 There may be scope for subsuming the activities of the Standards Committee into the Audit and Governance Committee whilst retaining the Sub-Committees that now undertake the bulk of Standards Committee activities. This is also an area for consideration in relation to shared services.
- 3.9 Consideration could also be given to reducing the size of the Appeals Committee from 9 Members to 3 Members in line with its quasi-judicial nature.
- 3.10 On the two current Joint Committees the Council is represented by Cabinet Members and the Chairman of the Audit and Governance Committee. There is a possibility that the North Yorkshire Audit Partnership Joint Committee may be dissolved if new arrangements for North Yorkshire audit services are approved from 2012. Membership on the Building Control Partnership has recently reduced from two Members to one.
- 3.11 The Area Forums membership is currently based on the Market Towns and their hinterlands.
- 3.12 The reduction in Scrutiny Committees and membership of Planning Committee and Cabinet in recent years has reduced the requirement for attendance of Members at formal meetings. Leaving aside Full Council and Area Forums, on which all Members are represented, the number of required Member attendances has dropped by 33% since 2009.
- 3.13 A potential comparison of arrangement (between current and possible), based on the suggestions in paragraphs 3.7 to 3.9 above indicates that the number of Members required to fulfil the roles could be reduced. This could reduce required Member attendance by a further 6.75% on 2008/9 levels.
- 3.14 There may also be scope for reviewing the Council's involvement with outside bodies, which has grown on an ad-hoc basis over the years.
- 3.15 All of these changes would require more formal consideration and approval by Council, but they do indicate that potential amendments to the Council's organisational arrangements could fit with a reduction in Councillor numbers without overburdening the remaining Councillors in terms of attending meetings.
- 3.16 In terms of the amount of time required by Members to fulfil their role outside formal Council structures, the proposal to reduce the number of Members by up to half suggests that, unless workloads reduce, then the remaining Members would have twice as much Council work (e.g. in constituencies) to undertake although generally with modern communications and customer awareness it is accepted that case work levels have dropped.

- 3.17 Feedback from Parish Councils/Meetings is summarised in Annex 2. Although there is some support for a reduction in numbers to 22 there is significant support from those who responded for a lesser reduction.
- 3.18 The comments of District Councillors are summarised at Annex 3. A number of Members support a smaller reduction than 50%.

4.0 WARDING ARRANGEMENTS:

- 4.1 Council size is used as the starting point to establish the average number of electors to be achieved across all Wards of the District. The optimum number of electors per Councillor is devised from dividing the electorate by the number of Councillors on the Authority.
- 4.2 It is not feasible to have the exact same number of electors per Councillor and still seek to meet other benefits such as co-terminosity of parish and County Division boundaries. However, the intention is to get as close as possible to this ratio throughout the District which will also include some projections on future growth. The LGBC indicate that it will need strong justification to depart from this level of representation.
- 4.3 The LGBC, when determining whether existing arrangements need to be reviewed, bases its decision on how many Wards have a discrepancy of plus or minus 10% of the average for the District as a whole. It therefore seems reasonable to accept such a tolerance of +/- 10%.
- 4.4 The other factors to be taken into account are "community identity" and "effective and convenient Local Government". The LGBC accepts that these are difficult to define. Community identity may be based on geographical or historical factors or may relate to the location of facilities as well as population/employment groupings. When looking at effective and convenient Local Government, the effect of proposals on individual Councillors may be relevant (i.e., their ability to travel around a Ward or represent the number of parishes contained in the Ward).
- 4.5 The Commission will seek to achieve as much co-terminosity as possible between County Divisions/District Wards and parish boundaries. Wards split into two geographically separate areas will not generally be supported.
- 4.6 Finally, in considering single or multi-Member Wards the Commission will be looking at the benefits to electors rather than local political organisations.
- 4.7 With the above in mind, we have taken as our starting point an assessment of the current County Divisions and parishes as they relate to existing District Wards. County Divisions are currently almost entirely co-terminous with District Wards and parish boundaries. This is indicated on Plan 1 which shows County Divisions, District Wards and parishes.
- 4.8 Although there was some support amongst Parishes and District Members for Warding arrangements based on 22 Members, there were also a significant number who felt that other options should be looked at. This report therefore reminds Members of the original proposal, but includes a further two alternatives.

A Council of 22

- 4.9 Given that there are 11 County Divisions, if the Council considers that 22 is the appropriate number of Councillors and the electorate as at 1 September 2011 was 71,263 then the optimum number of electors per Councillor is 3,239, an exercise was undertaken in identifying two potential District Wards per County Division. Each County Division currently contains District Wards comprising a total of 4 District Councillors. The intention was therefore to halve the number of District Councillors in each County Division. The resulting proposal is contained on Plan 2 and is accompanied by a Schedule indicating how existing Wards have been combined, the revised Member numbers and the resulting electorates of the proposed new 15 Wards.
- 4.10 In order for the new Wards to be within the tolerances referred to in paragraph 4.4 above, the electorates would have to be within the following ranges:-
 - 1 Member Ward Electorate between 2, 915 and 3,563
 - 2 Member Ward Electorate between 5, 831 and 7,125

It will be seen that the proposals bring all but the proposed Wards 3 and 14 within the ranges required using a combination of 1 Member and 2 Member Wards. The electorate of each parish is also attached.

4.11 The proposals are based on electorates as at 1 September 2011. An attempt has been made to project electorates over the next 5 year period and this is shown in a separate Schedule and shows that two Wards would be outside the range.

A Council of 28

- 4.12 For a Council of 28 the tolerances referred to in paragraph 4.4 would mean the electorate would have to be within the following ranges:
 - 1 Member Ward Electorate between 2,291and 2,800
 - 2 Member Ward Electorate between 4,581 and 5,599
 - 3 Member Ward Electorate between 6,872 and 8,399

The proposal is shown on Plan 4 and has an associated schedule. It has a combination of 1, 2 and 3 Member Wards which remain co-terminus with parish boundaries, but not County Divisions. Proposed Ward 3 is outside the tolerances. The five year projection shows three Wards (3, 7 and 10) outside the tolerances.

A Council of 32

- 4.13 For a Council of 32 the tolerances referred to in paragraph 4.4 could mean the electorates would have to be within the following ranges:
 - 1 Member Ward Electorate between 2,004 and 2,450
 - 2 Member Ward Electorate between 4,009 and 4,899
 - 3 Member Ward Electorate between 6,013 and 7,349

The proposal is shown on Plan 3 and has an associated schedule. It has a combination of 1, 2 and 3 Member Wards which is co-terminus with parish boundaries and County Divisions. All of the Wards are within tolerances except Ward 1. The five year projection shows three Wards (1, 3 and 10) outside the tolerances.

5.0 NEXT STEPS:

- 5.1 The Working Group should make recommendations to Council for its meeting on 21 February 2012. This will form the basis of the Council's initial representations to the Local Government Boundary Commission.
- 5.2 The Commission will be undertaking further formal local consultation during 2012 and individuals, groups and organisations will be entitled to make representations direct to the Commission during that consultation.

Council size meetings: Framework for discussion with the Council.

General council size questions

The following is divided into four key areas with sub headings for prompts:

- Managing the business of the Council: To what extent is council size influenced by the council's decision-making process or, conversely, the decision making structure fitted around the council size?
 - (a) What is the overall structure of decision making? Do Councillors match the work to fit the time available to them, or stretch/shrink the time they spend according to how much work they want to/ need to do?
 - (b) Has the Council studied how much time their members spend on Council business?
 - (c) What assessments have been made of how many members it needs to function effectively, particularly since the introduction of executive arrangements? In a hypothetical scenario where the council size was increased or reduced by 10%, how would you do things differently?
 - (d) To what extent is the current council size a factor in determining the political management, scrutiny and governance arrangements or is it the other way round?
 - (e) If you had a free hand, are there any changes you would make to the political management, scrutiny and governance arrangements? If so, how might that impact on the number of councillors required.
 - (f) How are decisions 'cascaded' down the structure? Is the balance between member decisions and officer delegated decisions effective? Is there any duplication of work?
- Scrutiny of the Council, outside bodies and Others
 - (a) What's the structure? An overview and scrutiny committee, or several scrutiny committees? How do subjects get tackled in Committee or Task & Finish Groups? How many subjects at any one time? What's the time-span for a particular study?
 - (b) Is Scrutiny just the Councillors doing meetings or do they take external evidence?
 - (c) If the former, what do the members do between meetings?

- (d) How is the Council handling health scrutiny who is involved? How much work do they do?
- (e) How many twin-hatted members sit on outside bodies and how are conflicts of interest resolved?

Representational Role: Representing Electors to the Council

- (a) What sort of engagement is there between front-line councillors with electors? One—to-one when there's a customer complaint, or gathering views about policy from the whole community? If the latter, how?
- (b) What is the structure of local area committees. What are their responsibilities? Is membership limited to councillors? is it open to district councillors or co-option from the wider community?
- (c) Do Councillors fix day-to-day problems by taking them to officers or by representing elector issues as policy views in meetings of the Council?
- (d) How does the Councillor engage? Surgery, newsletter, blog, public meetings, or not at all?
- (e) What do officers do to facilitate councillor engagement?

Representing the Council in the community

- (a) Does the councillor go to meetings of community bodies, parish councils? If so, how many? what for? Do councillors feel obliged to go to meetings of each individual parish council in their respective divisions or is it to meetings of "clusters" of parishes? Where the former, is this an effective use of an elected members time?
- (b) Does the Council attract candidates and retain members?
- (c) Are Councillors "go-betweens" between clients/customers/electors and paid service staff to fix service delivery complaints?
- (d) What happens when a Councillor is absent? Formal taking on of responsibility by other elected members, informal contact point for electors, or nothing? (Maybe different in multi-member wards). Do front line councillors take the strain of, for example Executive members whose time maybe limited?
- (e) Do Councillors learn and develop on the job or in formal training?
- (f) Has the Council experienced any statutory or other failures because there weren't enough councillors? Are Councillors bored or "inventing" work to do?
