CA.64 FORUM CAR PARK AND OTHER PARKING RELATED ISSUES

The subject of the decision:

Amended parking charging would take with effect from April 2013. In order for the changes to be implemented at the Forum car park in Northallerton a new Parking Amendment Order was required. Other arrangements including signage and software changes connected to the use of all the Council's charging car parks were required at a cost of £9,500.

Alternative options considered:

None.

The reason for the decision:

Cabinet was satisfied that the proposals aligned with the Council's priorities and improved the service for customers.

THE DECISION:

- (1) authorisation be given for capital expenditure of £15,500 in works associated with introducing amended parking tariffs at charging car parks from April 2013;
- (2) approval be given for the making of a Parking Amendment Order creating long-stay and short-stay sections at the Forum Car Park as shown on the plan attached under Annex B to this report, with effect from 15 May 2013;

- (5) approval be given for the necessary Consolidation Order to facilitate the implementation of Civil Parking Enforcement.
