Subject: CAPITAL GRANT FOR THE WORLD OF JAMES HERRIOT

1.0 PURPOSE AND BACKGROUND:

- 1.1 The purpose of this report is to seek approval to allocate a grant of £12,000 to the Herriot Country Tourism Group. The capital will be used to support improved levels of income generation for The World of James Herriot through the installation of a memorabilia room in the attraction.
- 1.2 The District Council agreed on 21 February 2012 to transfer The World of James Herriot from a Council managed service to a new company with community interest and with a particular focus on tourism. As part of that decision, Cabinet agreed to make a provision of £50,000 of capital to invest in the facility subject to further reports. Cabinet approved a grant of £37,440 to the Group in September 2012 for the installation of solar panels and the development of an electronic marketing application. The £12,000 grant will be the final allocation of the remaining capital.
- 1.3 The proposal involves the purchase of the largest collection of James Herriot memorabilia from a private collector and the necessary works required to display it in one of the rooms at the attraction. This addition will provide an opportunity to further promote The World of James Herriot through their website, e-marketing tools and leaflets.

2.0 LINK TO COUNCIL PRIORITIES:

2.1 This decision will support the Council in achieving its priority of supporting local economic growth, enabling The World of James Herriot to improve its financial position in line with its Business Plan.
