P.6 **MINUTES**

THE DECISION:

P.7 PLANNING ENFORCEMENT CHURCH FARMHOUSE, THORNTON LE STREET

Thorntons Ward

The subject of the decision:

The Director of Housing and Planning Services asked the Committee to determine the appropriate enforcement action to be taken in respect of identified breaches of planning control for the storage and maintenance of fairground lorries at Church Farmhouse, Thornton le Street.

Members had previously considered the merits of the proposal for storage of fairground lorries and resolved to grant planning permission. However, officers had subsequently come to the conclusion from evidence of actual use of the site that the "storage" went beyond simple storage and involved significantly more "maintenance" than originally assumed. Evidence also existed of breaches of planning control of both 'operational development' and a 'material change of use'.

Alternative options considered:

Not to take enforcement action.

The reasons for the decision:

The continuing affects on local amenity needed addressing.

THE DECISION:

That an enforcement notice be issued requiring the:

- (1) removal of hardstanding and restoration of the land to its former condition as ménage, grassland and hardstanding or in the alternative entirely as grassland, allowing 6 months for the completion of the work;
- (2) cessation of the use of the site for the storage and maintenance of fairground equipment, allowing 2 weeks for compliance.

(Mr Waller spoke on behalf of Thornton le Street Parish Council supporting enforcement action.)
