# P.18 ENFORCEMENT MATTERS – BAGBY AIRFIELD, BAGBY

White Horse Ward

#### The subject of the decision:

The Director of Corporate Services and the Director of Housing and Planning Services asked the Committee to consider the enforcement position at Bagby Airfield near Thirsk which was in part a response to an investigation by the Local Government Ombudsman and a finding of maladministration against the Council.

In determining the next steps in respect of Bagby Airfield Members gave consideration to the Ombudsman's report, recent enforcement action, further enforcement action and the possibility of making a Discontinuance Order.

Members concluded that given the ability of the Council to take enforcement action against the airfield it was considered appropriate to follow this approach to regularise the position at the airfield and that a Discontinuance Order could be considered further following the outcome of enforcement action.

To make a Discontinuance Order

# The reasons for the decision:

To resolve the issues and Bagby Airfield.

# THE DECISION:

That:

- (1) a Discontinuance Order be not made at this time;
- (2) following further legal advice, the Directors of Housing and Planning and Corporate Services be authorised to issue Enforcement Notices in respect of;
  - (a) the Jet A1 fuelling point;
  - (b) reducing the number of aircraft movements on the main runway, the use of the clubhouse/control tower and such other uses as they consider appropriate;
- (3) a request be made to Cabinet to agree to provide additional funding up to £32,000 to support enforcement action.
